- d. The rate once quoted and approved shall be the final and no changes will be accepted at a later stage.
- e. No additional charges will be borne by this office other than the rate quoted.
- f. Rates quoted should be inclusive of installation charges and other accessories.
- g. Additional requirement of Cat 6 Cable if any, shall be supplied at your scope.
- h. 2 Nos. of Manpower service support (1 at day time and 1 at night time) shall be provided round the clock to attend faults if any, for which a separate quotation shall be submitted to this Office.
- The rate quoted should be inclusive of GST.
