WHEREAS, in the wake of the Novel Corona Virus (COVID-19) outbreak which has been declared as a Notified Disaster under the provision of Disaster Management Act, 2005, has prompted this UT Administration to take several preventive measures.

AND WHEREAS, due to sudden surge in the number of Covid positive cases, the number of persons under Home Quarantine and Covid positive cases under Home Isolation have drastically increased.

AND WHEREAS, the Incident Commander were authorized to file a complaint on the cases of violations of Quarantine being reported by Police /Health Department vide order third cited.

AND WHEREAS, complaints are being received about jumping of Home Quarantine, which poses a serious threat for further spread of Covid-19.

NOW THEREFORE, in exercise of the powers vested with me under the Disaster Management Act, 2005 and the Epidemic Disease Act, 1897, I hereby order the following:

- (i) The Revenue, Health and Police Department shall be vigilant about the persons in home quarantine and Covid-19 cases under home isolation by making frequent and random visit to house to ensure the persons is under quarantine and also by use of technology (CTQW, CQAS etc)
- (ii) The Incident Commander shall file a complaint on the cases of violations being reported by the Police/Health Department and the violators shall be shifted to Institution quarantine.

The authorities concerned shall comply with the above instructions.
