The Novel Corona Virus (COVID-19) situation which has been declared as a Disaster under the provision of Disaster Management Act, 2005, has prompted this District Administration to take several preventive measures.

Various orders and instructions have been issued by the undersigned to restrict the movement of people and ensure essential services/ activities. The Ministry of Home Affairs, Govt. of India has issued guidelines to be observed during the lock down period of 21 days from 25 03.2020. As per which, the District Magistrate ought to deploy Executive Magistrates as Incident Commanders in local jurisdiction and the Executive Magistrates will be responsible for the overall implementation of containment measures in their jurisdiction.

Accordingly, the Tahsildar/Deputy Tahsildar-cum-Executive Magistrate of Taluk/ Sub-Taluk Offices are designated as Incident Commanders in their respective jurisdiction under the overall supervision of the Sub-Divisional Magistrate concerned in preventing and mitigating the pandemic. Within their jurisdiction, they will ensure movement of essential goods and people engaged in essential services and activities. They will sort out all complaints received by them with utmost earnestness. ESF/ Line department officials in their

respective jurisdictions shall comply with the directions of the Incident Commanders.
