**Sub:** DM - COVID-19 - Dedicated 300 beds for Covid-19 treatment in Private Medical College Hospital - Orders - Issued.

Whereas, in the wake of the Novel Corona Virus (COVID-19) outbreak which has been declared as a Notified Disaster under the provision of Disaster Management Act, 2005, has prompted this UT Administration to take several preventive measures.

Whereas, Indira Gandhi Medical College & Research Institute, Kathirkamam Puducherry has been declared as a Covid Hospital by this Administration.

Whereas, in view of the worsening Covid-19 crisis and the existing Medical facilities have saturated, the Director, of Health & Family Welfare Services, Puducherry has informed that there is an urgent need of more dedicated Covid Hospitals to take care of the Covid patients requiring medical attention.

Whereas, the Private Medical College Hospitals in Puducherry have come forward to provide 300 beds by each Hospitals for treating Covid-19 positive cases.

Now Therefore I, Dr. T. Arun, IAS, in the capacity of District Magistrate, Puducherry in exercise of the power conferred under the Epidemic Diseases Act, 1897 and the Disaster Management Act, 2005, do hereby order that:

(i) The following Private College Hospitals shall dedicate 300 beds for treating Covid-19 patients referred by the Government of Puducherry.

- (ii) Admission of Covid-19 positive cases in these Hospitals shall be made as per the directions of the Director of Health & Family Welfare Services, Puducherry.

The authorities concerned shall comply with the above instruction.
