ANNEXURE

1. **PAY:**

During the period of Foreign Service Thiru M. Kasinathan, Tahsildar will have the option either to get his pay fixed in the deputation post under the operation of the normal rules or to draw pay of the post held by him in his parent Department without Deputation (Duty) allowance.

2. DEARNESS ALLOWANCE AND OTHER ALLOWANCES:

During the period of foreign service, he will be entitled to dearness allowance under the rules of the parent Government or under the rules of the borrowing Government accordingly as he retains his scale of pay under the parent Government or he draws pay in the pay scale attached to the post under the borrowing Government.

3. LEAVE:

During the period of Foreign Service, he will continue to be governed by the leave rules applicable to him in the grade in his parent department.

4. DISABILITY LEAVE:

The above borrowing authority will be liable to pay leave salary in respect of special disability leave granted to the above official on account of any disability incurred through Foreign Service under the borrowing authority even if such disability manifests itself after the termination of foreign service.

5. COMPENSATORY ALLOWANCE:

The whole expenditure in respect of Compensatory allowance for the period of leave in or at the end of the Foreign Service shall be borne by the said borrowing authority.

6. TRAVELLING ALLOWANCE;

For journey on duty in Foreign Service, the traveling allowance rules of the Central Government would apply.

7. **LEAVE TRAVEL CONCESSION:**

During the period of Foreign Service, he will be entitled to travel concession as admissible under the Central Government Rules, the liability in this regard being borne by the said borrowing authority.

8. MEDICAL FACILITIES:

During the period of Foreign Service, he will be entitled to medical facilities and educational concession not inferior to those he would have enjoyed had he remained in the service of the Government. / / /
