WHEREAS, the Directorate of Higher and Technical Education has proposed for establishment of Government Engineering College at Yanam under the Centrally Sponsored Scheme "Rashtriya Uchcharat Shiksha Abhiyan" (RUSA phase 2).

2. AND WHEREAS, the Deputy Collector (Revenue) Yanam has identified a portion of the Government land situated at Ward-G, Block-2, T.S.No.6/1/1312 of Iskitippah Revenue Village and furnished the land particulars along with the technically scrutinized sketch of the identified land.

3. AND WHEREAS, the proposal was examined in the light of the provisions contained in Rule 310(2) of General Financial Rules, 2017, which stipulates the modalities for transfer of land from one Department of the Government to another and found to be in order.

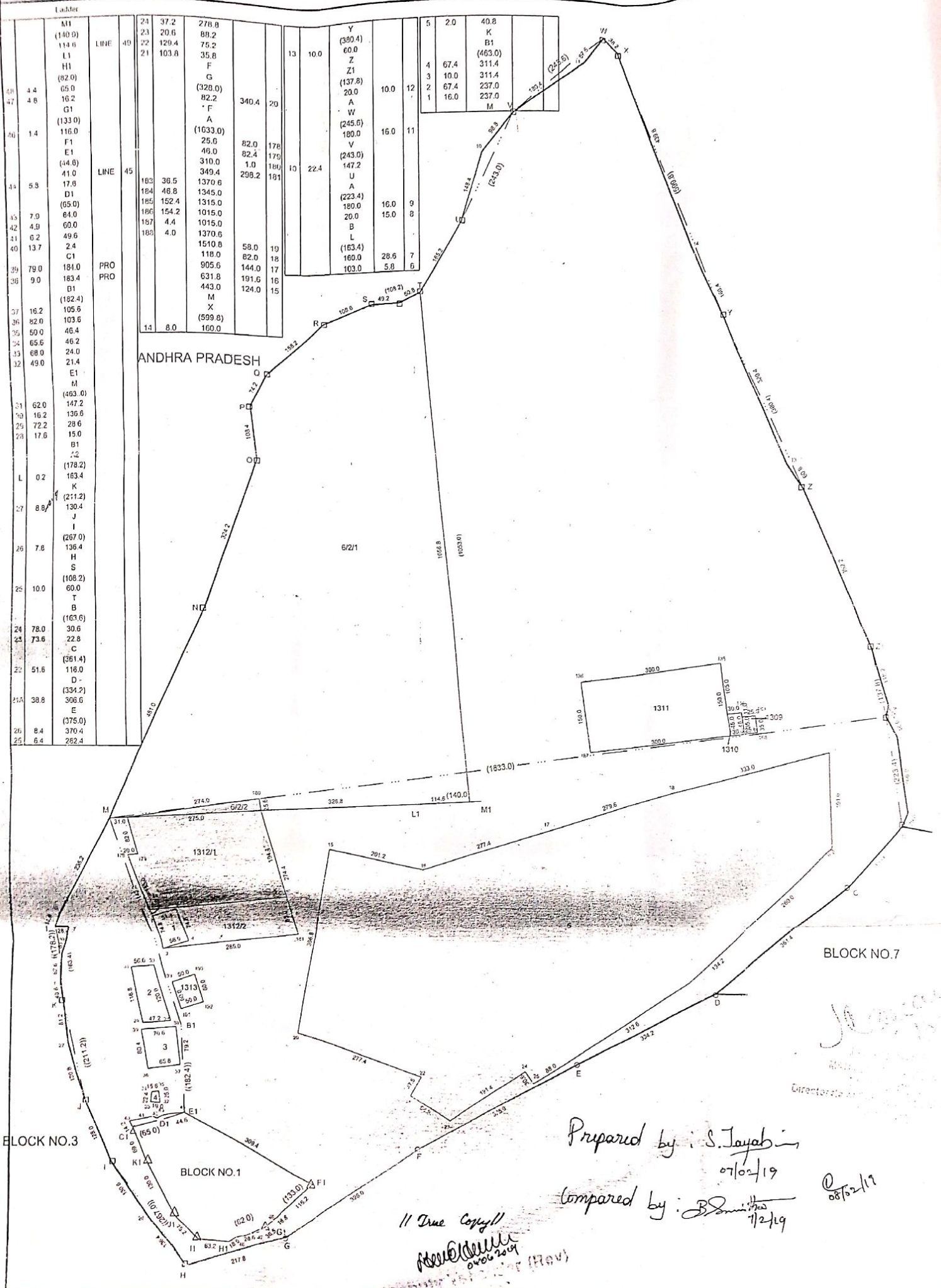
