ORDER

The Rajiv Gandhi Social Security Scheme for Poor Families' 2012 notified vide order read above, is being implemented by the Department of Revenue and Disaster Management, Government of Puducherry for granting financial assistance to all the members of families below poverty line in the Union Territory of Puducherry in the event of death or partial or permanent total disability of their family members in the age group of 18-60 years.

2. Accordingly, sanction of the Lieutenant Governor is hereby conveyed to incur an expenditure not exceeding ₹.1,59,45,000/- (Rupees one crore fifty-nine lakhs and forty-five thousand only) towards the grant of financial assistance to **467 beneficiaries/claimant** who have lost their family members due to natural and unnatural death, partial total disability and permanent total disability due to accidents in the Union Territory of Puducherry under the provisions of "Rajiv Gandhi Social Security Scheme for Poor Families, 2012" as detailed in the annexure.

3. As the general elections to the Lok Sabha 2019 was notified by the Election Commission of India on 10.03.2019, the proposal was referred to the Screening Committee for clearance through Nodal Officer(MCC) and Chief Electoral Officer. The Screening Committee suggested that the funds may be withdrawn and kept in personal ledger and then disbursed to eligible beneficiaries after the elections so as to avoid lapse. In accordance with the direction of the Screening Committee for election, the entire amount shall be drawn and deposited in the official account of the Special Officer-cum-DDO, Office of the Special Secretary(Rev), Puducherry bearing Current Account No.30928404361 at SBI, Puducherry until the date of conclusion of Model Code of Conduct for General Election to the Lok Sabha-2019 and later the same shall be disbursed to the beneficiaries accounts through ECS.

4. The expenditure is debitible under the Head of Account "2235-Social Security and Welfare – 60 –Other Social Security and Welfare Programme – 60/101(01) – Group Personal Accident Insurance Scheme for Below Poverty Line family members in the Head of Account 60/101(01)(01) Puducherry region – 50 Other Charges " in the budget.

5. This issues with the concurrence of the Finance Department, Puducherry vide their I.D.No.3280/FC/F4/A3/2018-19, dt.27.03.2019.
