NOTIFICATION

In exercise of the powers conferred by the proviso to article 309 of the constitution of India read with Notification No. F5/4/65-GP., dated the 11th January, 1965 of the Ministry of Home Affairs, Government of India, New Delhi and in supersession of the Revenue Department's, G. O. Ms. No. 176, dated 22nd September 1977, the Lieutenant-Governor, Pondicherry, hereby makes the following rules regulating the method of recruitment to Group 'C' posts of Sub-Registrar in the Registration Department,

- 1. Short title and commencement .—(1) These rules may be called the Government of Pondicherry, Revenue Department, Group 'C' post of Sub-Registrar Recruitment Rules, 1982.
 - (2) They shall come into force from the date of their publication in the official gazette.
- 2. Number of post, its classification and scale of pay.— The number of the said post, its classification and the scale of pay attached thereto shall be as specified in columns 2 to 4 of the schedule annexed hereto.
- 3. Method of recruitment, age limit and other qualifications.—The method of recruitment, to the said post, age limit, qualifications and other matters relating thereto shall be as specified in columns 5 to 13 of the said schedule.
 - 4. Disqualifications.—No person,—
 - (a) who has entered into or contracted a marriage with a person having a spouse living, or
- (b) who, having a spouse living has entered into or contracted a marriage with any person, shall be eligible for appointment to the said post:

Provided that the Lieutenant-Governor may, if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and there are other grounds for so doing, exempt any person from the operation of this rule.

- 5. Power to relax.—Where the Lieutenant-Governor is of the opinion that it is necessary or expedient so to do, he may, by order, for reasons to be recorded in writing, relax any of the provisions of these rules with respect to any class or category of persons.
 - 6. Savings.—Nothing in these rules shall affect,—
 - (i) the reservations, relaxation in age limit and other concessions required to be provided for the scheduled castes, the scheduled tribes and other special categories of persons in accordance with the orders issued by the Government from time to time in this regard; and
 - (ii) the appointments and recruitments already made in accordance with the recruitment rules hereby superseded.

** The promotes should pass the departmental tests within a period of one year from the date of appointment or to opportunities whichever is later and undergo the prescribed training, failing which they will be reverted.

A promotees reverted for having not passed the departmental test within a year or two opportunities as the case may be, will not be eligible for consideration for promotion to the post of Sub-Registrar till he has passed all the departmental tests prescribed for the post.

The direct recruits should pass all the tests and language tests prescribed for Sub-Registrar and undergo the prescribed training during the period of probation.
