In exercise of the powers conferred by section 22 of the Pondicherry Money Lenders' Act, 1970 (Act No.26 of 1970), the Lieutenant-Governor, Pondicherry, hereby makes the following amendments to the Pondicherry Money Lenders' Rules, 1970 published in the Extra ordinary Gazette No.113, dated 19<sup>th</sup> November, 1970, namely:-

AMENDMENT

In the Pondicherry Money Lenders' Rules, 1970,

- (i) in rule 3 and in rule 6(i) for the words "Tahsildar or Deputy Tahsildar as the case may be" the words "Sub/Assistant/Deputy Collector(Revenue)concerned" shall be substituted;
- (ii) in rule 15(1) for the words "Sub/Assistant/Deputy Collector (Revenue) having jurisdiction over the place of business of the money lender," the words "Joint Secretary (Revenue) exercising jurisdiction over the entire Union Territory of Pondicherry" shall be substituted.
- (iii) in Form A, for the words  
"The Tahsildar ..... Taluk"  
The Deputy Tahsildar, ..... Sub Taluk  
the words "Sub/Assistant/Deputy Collector(Revenue) concerned" shall be substituted;
- (iv) in Form B, for the words  
"The Tahsildar ..... Taluk"  
The Deputy Tahsildar, ..... Sub Taluk  
wherever they occur, the words "Sub/Assistant/Deputy Collector (Revenue) concerned" shall be substituted.
