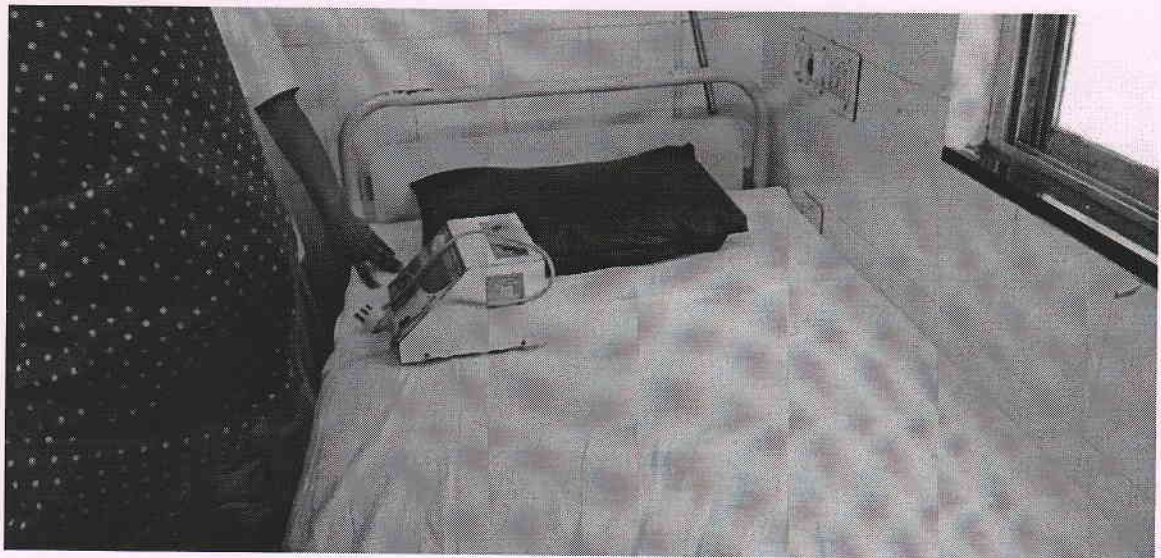
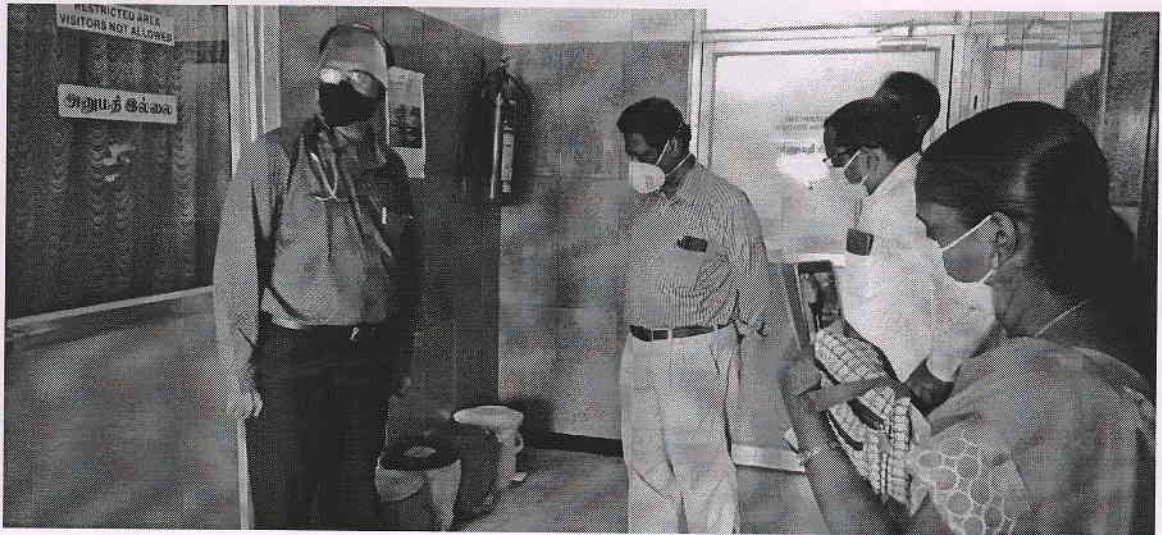
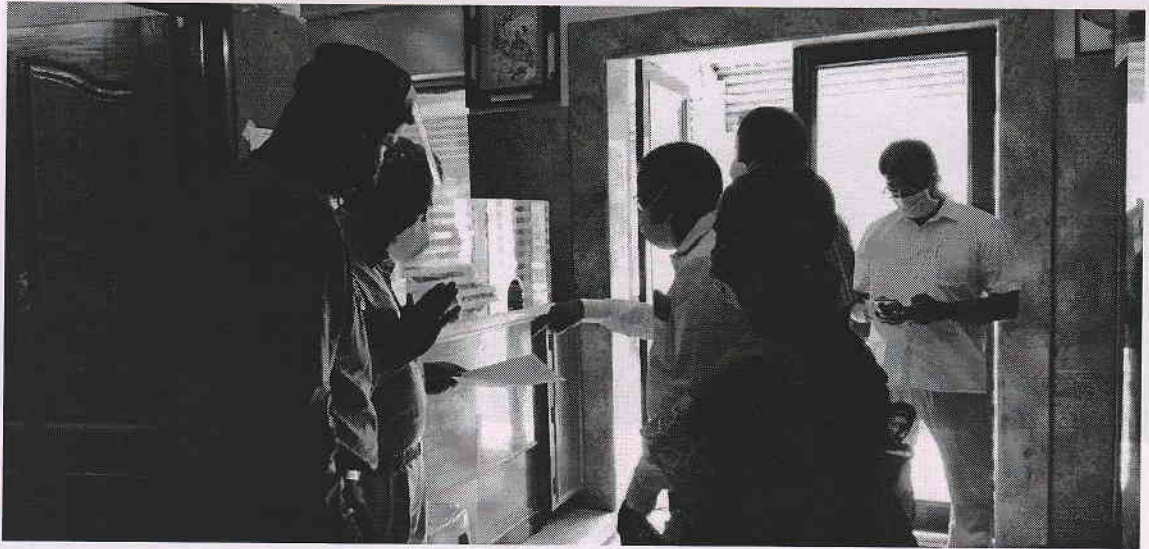
Observation : It was observed during the inspection that

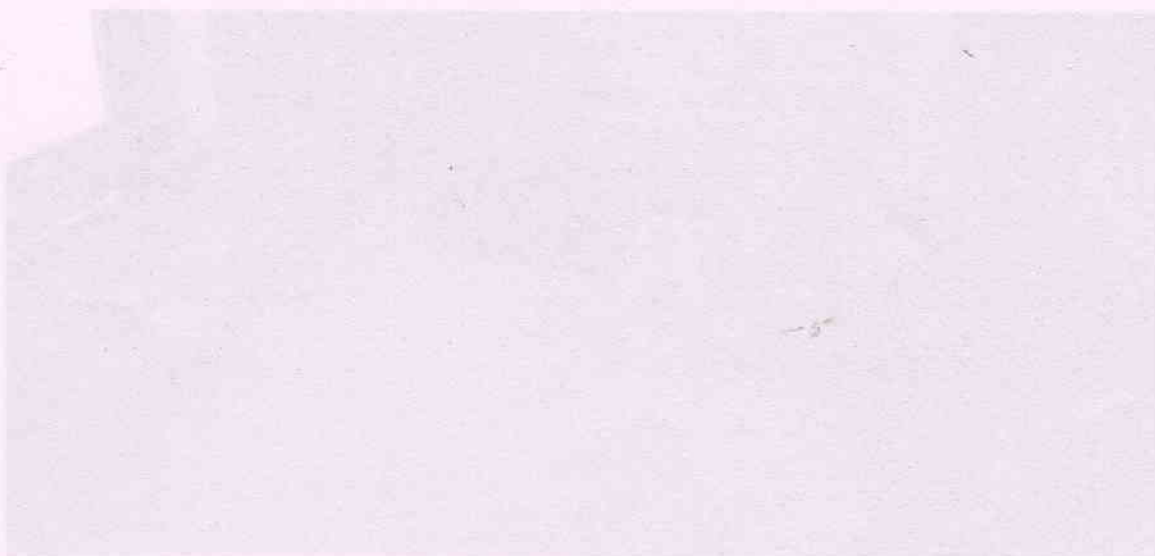
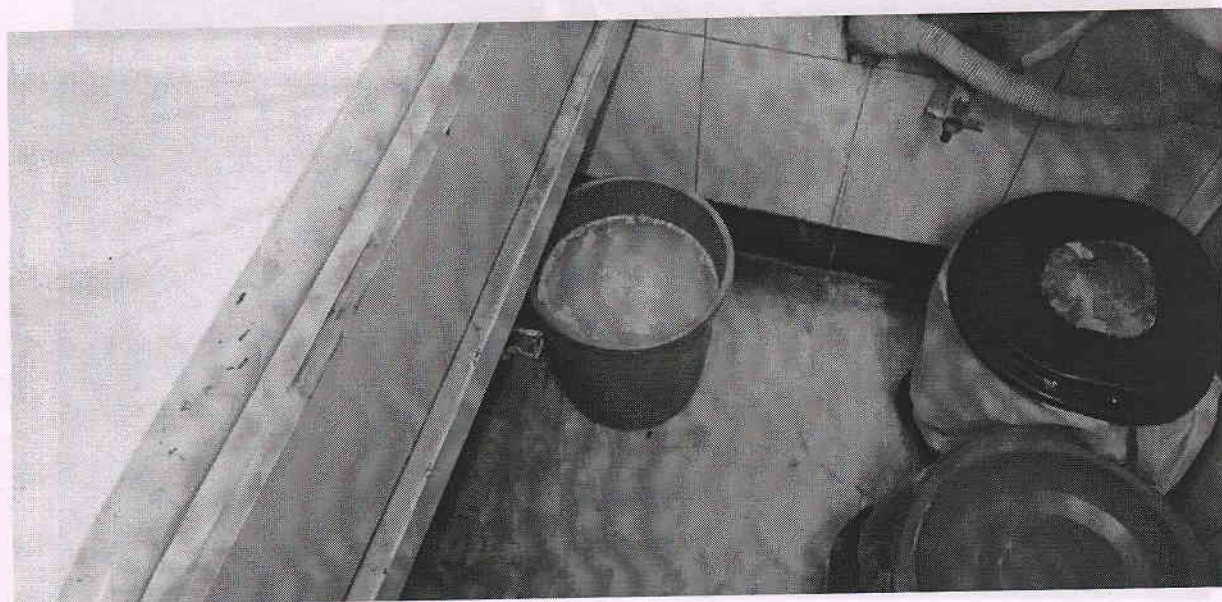
