In accordance with the guidelines issued *vide* G.O.Ms.No.06 dated 18.05.2022 of the Department of Revenue and Disaster Management, Puducherry cited under Ref. (1), the proposal for revision of Guideline Register (GLR) values for the financial year 2025–2026 has been duly examined and approved by the Council of Ministers in its meeting held on 23.04.2025 to adopt the GLR values finalized for the year 2022–2023 for the financial year 2025–2026, with prospective effect.

2. All the Sub/Deputy Collectors (Revenue) are hereby instructed to ensure that the revised GLR values, as finalized and approved for the year 2022–2023, are incorporated into the Guideline Registers without alteration (Soft copies of approved GLR values shall be shared through e-mail). A hard copy of the Village-wise (for Re- Survey)/ Ward-wise (for Town Survey) approved Guideline Value registers shall be maintained at the offices of the concerned Sub/Deputy Collectors (Revenue), District Registrar and the respective Sub-Registrars for reference.

3. Necessary coordination shall be ensured with the State Informatics Officer, National Informatics Centre (NIC), Puducherry, to carry out the technical integration and updation of the revised GLR data into the respective software of the Registration Department. The year-wise Guideline Values of the previous years have to be maintained electronically, and access to such database shall be made available to the general public and other Government offices. This process shall be completed immediately to facilitate smooth implementation.

4. The Memorandum cited at Ref. (2) is superseded with effect from the date of issue of this Memorandum.
