ORDER

Sub: TOB - COVID-19 - Establishment and Restriction in Micro Containment zone in Kuruvinatham/Seliamedu Revenue Village - Reg.

Ref: Circular No.214//DHFWS/2021 Dated:16/04/2021 of Director, Directorate of Health & Family Welfare Services, Puducherry.

In view of identification of 5 Positive cases of COVID-19 in each Kuruvinatham and Seliamedu Revenue Village pertaining to this Taluk jurisdiction on 06.05.2021, the following location have been declared as Containment Zone.

Sl.No.	Revenue Village	Address
1	Kuruvinatham	22 Mariyamman Koil Street Soriyankuppam
2	Seliamedu	23 Mariyamman Koil Street Kudiruppupalayam

Whereas, MHA, Government of India has prescribed the guidelines to be followed in demarcated zones and the roles and responsibilities are detailed here under.

There shall be strict perimeter control and the concerned Station House Officer shall ensure that there is no movement of people in or out of the zones except for medical emergencies and for maintaining supply of essential goods and services. All roads connecting the containment zone shall be guarded by police with Clear Entry and Exit Points.

The Medical Officer shall carry house to house surveillances by special team and clinical management of all cases as per protocol. Also to carry out testing in the locality.

The Commissioner, Bahour Commune Panchayat shall arrange wide publicity and community awareness on preventive measures such as wearing masks, hand hygiene and social distancing.

The Executive Engineer (PWD), B & R (S) shall make arrangements for regulating the movement of people in or out of these zones in consultation with Revenue and Police Officials.



Now therefore, it is requested for appropriate action and continuous monitoring in the containment zone so as to contain the spread of the infectious COVID – 19 disease.

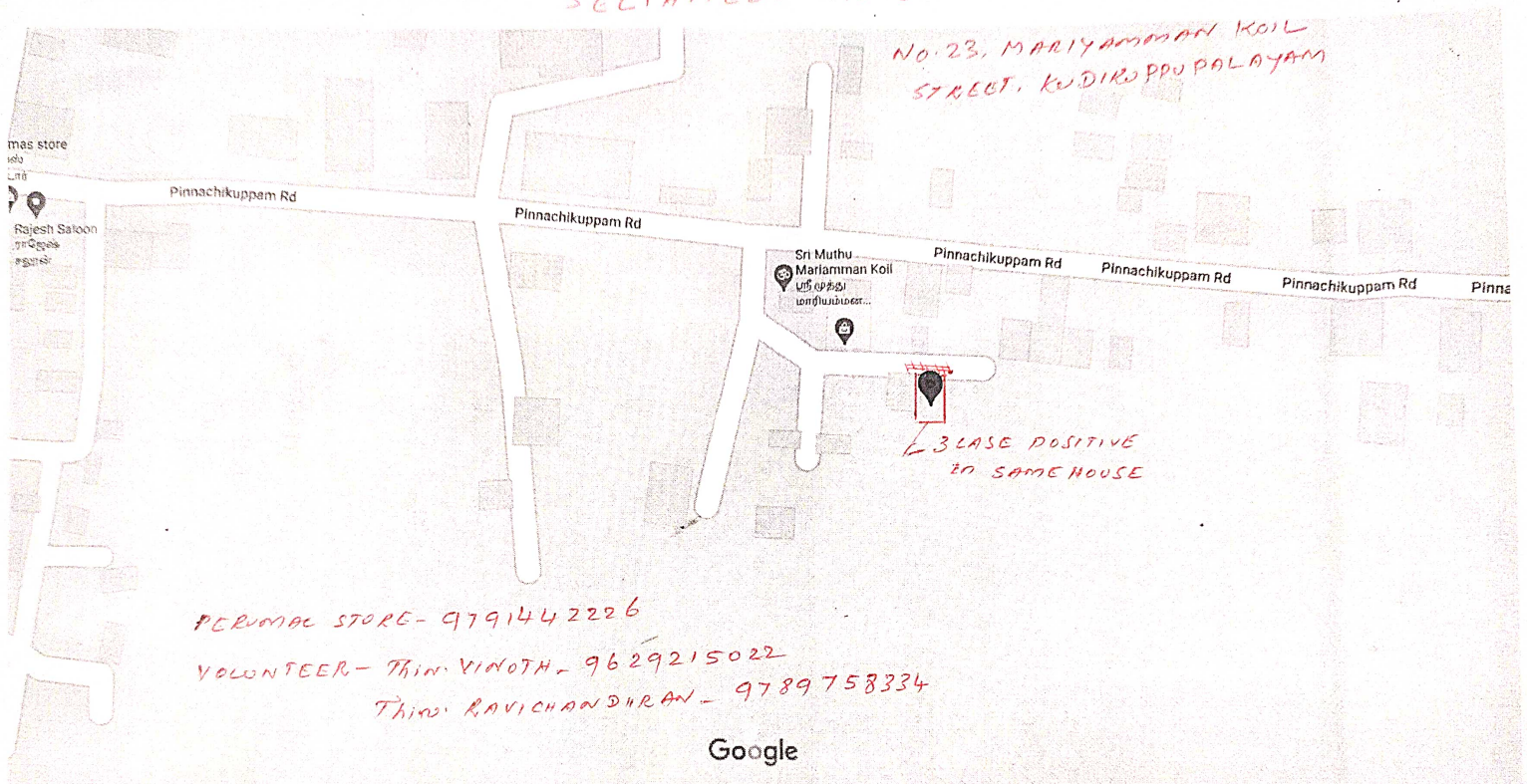
