ORDER UNDER SECTION 144 Cr.P.C

Whereas, in view of the visit of the Hon'ble President of India to Puducherry which is scheduled on 07.08.2023 and 08.08.2023, various security arrangements are being undertaken by this administration.

- 2. And Whereas, a request has been received from the Senior Superintendent of Police (L&O), Puducherry vide letter no. 81/SSP(L&O)-RD/2023-202, dt. 01.08.2023 to declare "No Fly Zone" within the District of Puducherry, during the visit of the Hon'ble President of India to Puducherry.
- 3. And Whereas, as a measure to strengthen security, there shall be restriction on use of Aerial photography / videography in any form by usage of Drones, balloons etc. and hence there is sufficient ground for proceeding for which immediate prevention is required.
- 4. Now, therefore, I, E. VALLAVAN, I.A.S, District Magistrate, Puducherry, in exercise of the power conferred upon me U/s 144 of the Criminal Procedure Code, 1973, with a view to ensure strengthen security during the visit of Hon'ble President of India to Puducherry on 07.08.2023 and 08.08.2023, declare the whole of Puducherry District as 'No Fly Zone' and do hereby prohibit the flying of any kind of aviation devices including UAV, Drones, balloons etc., in Puducherry District on 7th August 2023 and 8th August 2023.
- 5. Any violation of this order is punishable by legal action under section 188 of IPC and other relevant provisions of law.
- 6. This Order shall remain in force on 7th August 2023 and 8th August 2023.
- 7. The emergent nature of case and circumstances do not permit serving of notice to the concerned in due time and hence this order is passed ex-parte u/s 144(2) of the Criminal Procedure Code, 1973.
