MEMORANDUM

- Sub: DRDM Enquiry on Nativity/Residence Certificate and its Cancellation Instructions – Reg.
- Ref: 1. G.O.Ms. No.48 dated 12.12.2002 of the Department of Revenue and Disaster Management, Puducherry.
 - 2. Order No.6260/C2/Rev/2003 dt. 06.10.2003 of the Department of Revenue and Disaster Management, Puducherry.

Instances have come to the notice of the undersigned that the candidates are obtaining nativity/residence certificate from the taluk authorities by suppressing the facts or claiming dual residence for the purpose of higher studies in Puducherry especially for admission into medical courses through CENTAC and JIPMER.

For the purpose of issuing nativity/residence certificate, this department has already issued orders/instructions to the certificate issuing authorities vide reference 1st and 2nd cited. Wherein, the certificate issuing authorities have been strictly instructed to follow the guidelines and to issue certificates with due care and diligence after thorough field enquiry without any deviation.

As per this department's guidelines vide reference 2nd cited, the Sub/Deputy Collector (Revenue) concerned is the competent authority to direct the Tahsildar/Dy. Tahsildar to issue the residence certificate to the applicant on merits or to dismiss the application through a speaking order. Hence, complaints received regarding the genuineness of the nativity/residence certificate henceforth shall be enquired by the Sub/Deputy Collector (Revenue) concerned and after due enquiry, if it is found that, the candidate had obtained the nativity/residence certificate by wilful suppression of facts for purpose of availing dual benefits both in Puducherry and other States, such certificate should be invariably cancelled by the Sub/Deputy Collector (Revenue) concerned through a speaking order and necessary criminal action, wherever deemed fit, be initiated against the candidate or his/her parent for wilful suppression of facts. A report in this regard shall also be submitted to the District Collector concerned within 7 days from the date of issue of such order.

The above instructions shall be scrupulously followed and shall not give room for any complaints. Any deviation in this regard will be viewed seriously.
