WHEREAS, the Police Department has proposed for setting up of Coastal Police Station at Mahe;

2. AND WHEREAS, the Regional Administration has identified a parcel of the Government land situated at R.S.No.113 of Mahe Revenue Village to be suitable for setting up of Coastal Police Station at Mahe;

3. AND WHEREAS, the Deputy Collector (Revenue) Mahe has sub-divided the identified parcel of Government Poramboke land at R.S.No.113 with an extent of 01-51-00 Ha into R.S.No.113/1 and R.S.No.113/2 with an extent of 01-47-20 Ha and 00-03-80 Ha respectively and furnished the technically scrutinized sketch and land schedule details;

4. AND WHEREAS, the proposal was examined in the light of the provisions contained in Rule 310(2) of General Financial Rules, 2017, which stipulates the modalities for transfer of land from one Department of the Government to another on 'no profit no loss' basis;

5. NOW THEREFORE, approval of the Hon'ble Lieutenant Governor is hereby accorded for transfer of the following Government land at zero cost on 'no profit no loss' basis to the Police Department as detailed below:

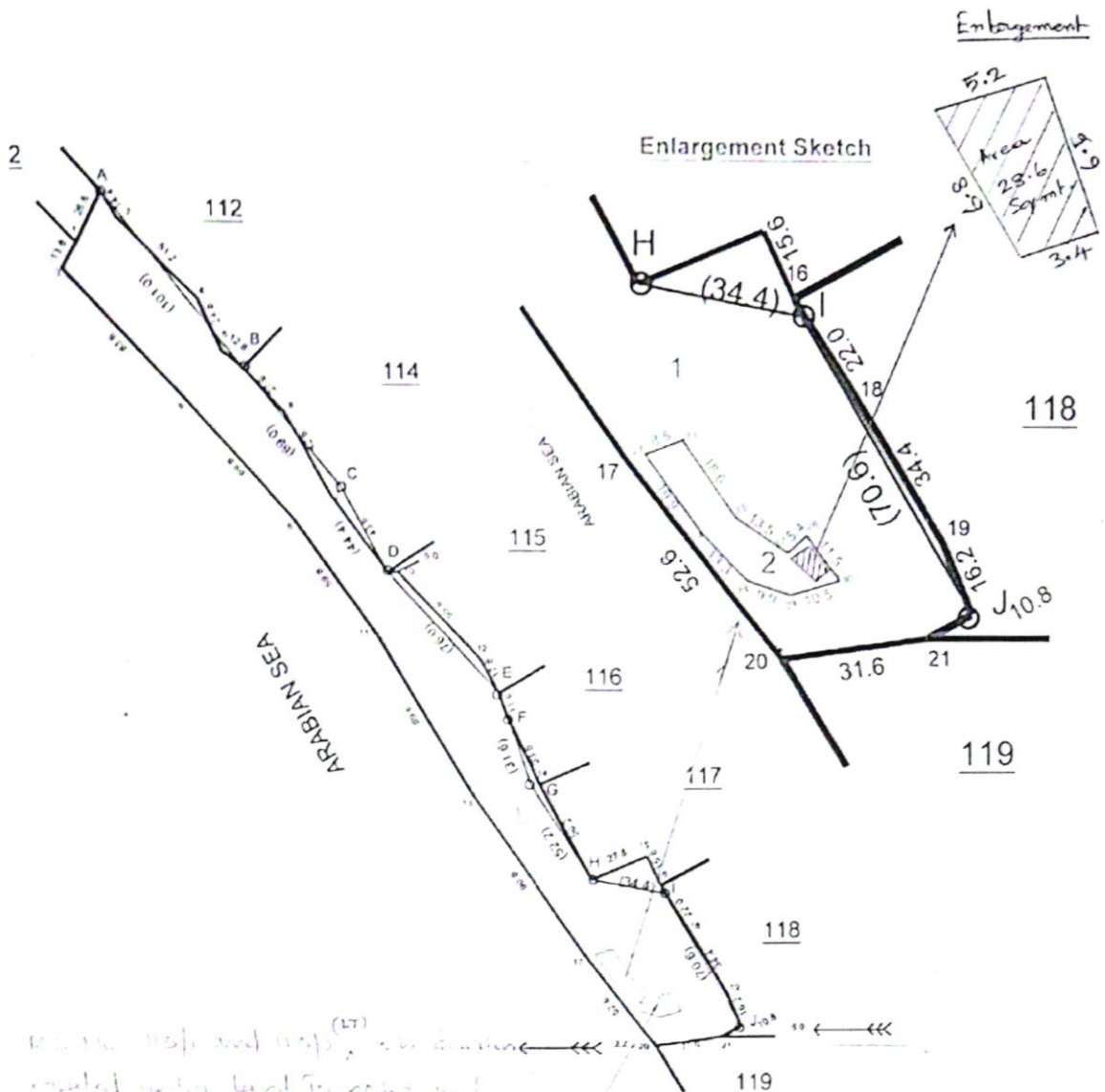
