Sub.: DOSLR - e-District - Revamp the procedure for receiving of Patta transfer/Sub-Divisions petitions and Demarcation petitions of Puducherry and Oulgaret Taluks –
Orders - Issued - reg.

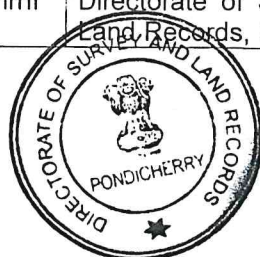
As per the PeGS Mission Mode Project, the e-District Project has been identified as one of the Project and Puducherry District is taken as pilot project. Under this e-District Project, it is proposed to take up huge volume of department services for back end automation. In respect of this Directorate, the Patta Transfer (Involving sub-division / Non involving sub-division) services have been identified and necessary software has been prepared and demo version is yet to be released. In the project all the services are done in Workflow method uniformly including the Patta Transfer. In the workflow method, the Patta Transfer petitions will be handled right from the VAO to the Tahsildar. Accordingly, the existing procedure in all the Taluk Offices of the Union territory shall be uniform. Therefore, if the e-District Project is implemented then this directorate will not receive any Patta Transfer /Sub-Divisions petitions.

2. Considering the above situations it is decided to stop receiving the Patta Transfer /Sub-Divisions and Demarcation petitions pertaining to Puducherry and Oulgaret Taluks by this Directorate from 01.07.2016, and the Tahsildar -cum Specified Officer, Puducherry and Oulgaret Taluk are instructed to receive the Patta Transfer /Sub-Divisions and Demarcation petitions from the public from 01.07.2016 onwards and process the applications as carried out by Villianur and Bahour Taluk Offices.

3. In this regard, a meeting was convened by the undersigned on 16.06.2016 with the Taluk Tahsildars. The Tahsildar, Taluk Office, Puducherry and Oulgaret has been informed about this proposal and the same was agreed by them.

4. However, In order to facilitate the Tahsildar -cum- Specified Officer, Puducherry and Oulgaret to handle the cases of patta transfer, subdivision and demarcation petitions as is being done in Villianur and Bahour Taluk Office the services of the following Deputy Surveyors/ Surveyors/Field Assistant are placed under the disposal of the Tahsildar -cum- Specified Officer, Puducherry and Oulgaret:


