ORDER:

The Lieutenant Governor of Puducherry is pleased to to approve dovetailing of “National Family Benefit Scheme” a component of National Social Assistance Programme of the Centrally Sponsored Scheme with the Union Territory of Puducherry’s scheme of “Rajiv Gandhi Social Security Scheme for Poor Families-2012” in the Union Territory of Puducherry.

2. The Ministry of Rural Development, Government of India, New Delhi is implementing the scheme for granting financial assistance to all the below poverty line family members @ Rs.20,000/- to bereaved household in the event of death of bread winner in the age group of 18-60 years, under the Centrally Sponsored Scheme of National Social Assistance Programme(NSAP) with the component “National Family Benefit Scheme” for implementation in the Union Territory of Puducherry. As per the guidelines and revised guidelines of the said Centrally Sponsored Scheme read 3rd above, the said amount will be extended as Union Territory’s Central Share.

3. The Department of Revenue & Disaster Management, Government of Puducherry is implementing the Union Territory scheme of granting financial assistance to all the below poverty line family members in this Union Territory in the event of death @ Rs.30,000/- in case of natural death and Rs.75,000/- in the case of un-natural death or Permanent Total Disability and Rs.37,500/- in the case of Partial Permanent Total Disability due to accident of their family members in the age group of 18-60 years under “Rajiv Gandhi Social Security Scheme for Poor Families-2012” notified vide orders 1st and 2nd read above with effect from 25.03.2011. Necessary application have been received from the respective Taluk and have been verified by the respective Thasildar concerned. The same has been approved/certified under Form ‘C’ by the concerned Deputy Collector(Revenue), Union Territory of Puducherry.

4. Based on the guidelines stipulated for the Centrally Sponsored Scheme of “National Family Benefit Scheme” and Rules framed for the Union Territory’s Scheme of “Rajiv Gandhi Social Security Scheme for Poor Families-2012” in the Union Territory of Puducherry on the implementation towards granting financial assistance to all the below poverty line family members of the bereaved household in the event of death of bread winner in the age group of 18-60 years is

similar on the both said schemes, As such approval is accorded to utilize the centrally sponsored scheme fund to the beneficiaries of Union Territory of Puducherry who have applied under the said Union Territory's scheme.

5. Accordingly, approval is also accorded to release the financial assistance of Rs. 30,000/- to each eligible beneficiary with Centrally Sponsored Scheme amount of Rs.20,000/- and Union Territory's budget fund of Rs.10,000/- with central share of 66.66% and Union Territory's share of 33.34%.

6. The Utilization Certificate on the central assistance funds have to be rendered to the Ministry of Rural Development, Government of India, New Delhi under intimation of the District Rural Development Agency, Puducherry which is the nodal department on the implementation of National Social Assistance Scheme (NSAP).
