The Rajiv Gandhi Social Security Scheme for Poor Families' - 2012 notified vide order read above, is being implemented by the Department of Revenue and Disaster Management, Government of Puducherry for granting financial assistance to all the below poverty line family members in the Union Territory of Puducherry in the event of death or partial or permanent total disability of their family members in the age group of 18-60 years.


2. In exercise of the powers conferred in G.O.Ms.No.47/F3/2014, dated 09.12.2014 of the Finance Department, Puducherry, sanction of the District Collector is hereby accorded for incurring of an expenditure not exceeding ₹99,90,000/- (Rupees Ninety Nine Lakh Ninety Thousand Only) towards payment of financial assistance to 297 beneficiaries/claimants who have lost their family members in the event of natural and unnatural death due to accidents in the Puducherry region under the provisions of "Rajiv Gandhi Social Security Scheme for Poor Families' - 2012" as detailed in the annexure.

3. Sanction is also hereby accorded to utilise the entire amount by way of issuing orders by the District Collector and presenting contingent bills to Directorate of Accounts, Puducherry. The Directorate of Accounts and Treasuries may scrutinise the bills and make payment to the eligible beneficiaries through Electronic clearing System (e-Payment) only.

4. This Expenditure Sanction is issued based on the Form-C sanction orders, issued by the concerned Sub/Deputy Collector(Revenue)-Cum-Settlement Officer in complying to the provisions of the Rules for the Grant of Financial Assistance under the Rajiv Gandhi Social Security Scheme for Poor Families' - 2012 vide G.O. first cited.

5. The expenditure is debitible under the Head of Account "2235 - Social Security and Welfare - 60 - Other Social Security and Welfare Programme - 60/200 - Other Programmes - 60/200(01) - Rajiv Gandhi Social Security Scheme for poor families - 60/200(01)(01) - Pondicherry Region - 49 Other Revenue Expenditure" in the Revised Estimate of the Financial Year 2024-25.
