ORDER

Sub: DRDM, Puduchery – Financial Assistance under RGSSSPF, 2012 to 88 beneficiaries for an amount of Rs.29,10,000/- Expenditure Sanction – Orders – Issued.

Ref : 1. This Department's G.O.Ms.No.14 dated 28.09.2012.
2. This Department's G.O.Ms.No.15 dated 28.09.2012.
3. G.O.Ms.No.47/F3/2014 dated 09.12.2014 of Finance Department, Puducherry.

The Rajiv Gandhi Social Security Scheme for Poor Families' 2012 notified vide order read above, is being implemented by the Department of Revenue and Disaster Management, Government of Puducherry for granting financial assistance to all the below poverty line family members in the Union Territory of Puducherry in the event of death or partial or permanent total disability of their family members in the age group of 18-60 years.

2. In exercise of the powers conferred in G.O.Ms.No.47/F3/2014, dt.09.12.2014 of the Finance Department, Puducherry sanction of the District Collector is hereby accorded for incurring of an expenditure not exceeding **Rs.29,10,000/-**(Rupees Twenty Nine Lakh and Ten Thousand only) towards the financial assistance to the **88** beneficiaries/claimant who have lost their family members in the event of natural and unnatural death, partial or permanent total disability due to accidents in the Puducherry region under the provisions of "Rajiv Gandhi Social Security Scheme for Poor Families, 2012" as detailed in the annexure.

3. Sanction is also hereby accorded to utilize the entire amount by way of issuing orders by the District Collector and presenting contingent bills to Directorate of Accounts, Puducherry. The Directorate of Accounts and Treasuries may scrutinize the bills and make payment to the eligible beneficiaries through Electronic clearing System (e-Payment) only.

4. This Expenditure Sanction is issued based on the Form-C sanction orders, issued by the concerned Sub/Deputy Collector(Revenue)-Cum-Settlement Officer in complying to the provisions of the Rules for the Grant of Financial Assistance under the Rajiv Gandhi Social Security Scheme for Poor Families-2012 vide G.O. 1st cited.

5. The expenditure is debitible under the Head of Account "2235-Social Security and Welfare – 60 –Other Social Security and Welfare Programme 60/200-Other Programmes – 60/200(01) – Rajiv Gandhi Social Security Scheme for poor families - 60/200(01)(01) Pondicherry Region – 49 Other Revenue Expenditure" in the Budget.
